DIRECT LOAN - UNSUBSIDIZED	\$	THE INTEREST IS NOT PAID BY THE FEDERAL GOVERNMENT WHILE THE STUDENT IS IN SCHOOL. INTEREST WILL BEGIN TO ACCRUE THE DAY THE LOAN IS FULLY DISBURSED AND CAN BE EITHER PAID WHILE THE STUDENT IS IN SCHOOL OR ADDED TO THE PRINCIPAL BALANCE OF THE LOAN WHEN IT ENTERS REPAYMENT SIX MONTHS AFTER THE STUDENT LEAVES SCHOOL.
