HEERF Update for the period of July 1 – September 30, 2021 (Q3)

Iowa Western Community College (Iowa Western) received a total of \$9,659,851 through the Higher Education Emergency Relief Fund (HEERF) as part of the Coronavirus Aid, Relief, and Economic Security Act (CARES), Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA), and the American Rescue Plan Act (ARP)—Award #P425E200910.

# CRRSAA, Section 314(a)(1)-FINAL REPORT

## **OVERVIEW**

lowa Western received a total of \$6,848,417 in additional HEERF funding as part of the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA), Section 314(a)(1). \$1,587,692 of this total was designated to be used toward student emergency financial aid grants. CRRSAA requires that an institution provide the "same amount" in student emergency financial aid grants that it was required to distribute from the original CARES Act HEERF award (\$1,587,692). lowa Western elected to distribute the funding for student emergency financial aid grants in two phases as detailed below.

Between July 1 and September 30, 2021, a total of 1,104 students received awards totaling \$288,600 from Phase II, Sessions II, III, and IV.

## **METHODOLOGY**

## PHASE TWO (SUMMER 2021):

## **ELIGIBILITY**

As of September 30, 2021, a total of 1,219 lowa Western students met the eligibility criteria.

- Must be enrolled for a complete 2021 Accelerated Summer Session (Summer Session I, Summer Session II, Summer Session IV),
- Must be degree seeking,
- Must not be an international student, and
- Must not have received a CRRSAA student assistance grant for any other 2021 Accelerated Summer Session.

#### **DISTRIBUTION**

Awards will be distributed to all eligible students based on the EFC on their current FAFSA. Students without a FAFSA on

file will be considered low need.

- High need EFC= \$0-\$5,575
- Moderate need EFC= \$5,576-\$20,000
- Low need EFC= \$20,001+, or no FAFSA on file

Award values will be preset and based on criteria. No application is required.

- High need= \$350
- Moderate need= \$250
- Low need= \$100

Session III includes the regular summer session along with accelerated sessions that ended on the same date. All qualifying students were notified of their awards through email. Awards were distributed based on the students' identified preference of debit card, bank account or check.

# ARP, Section 2003(a)(1)

#### **OVERVIEW**

Iowa Western received \$6,214,467 in additional HEERF student aid funding as part of the American Rescue Plan (ARP), Section 2003(a)(1). As of September 30, 2021, 3,478 student financial aid awards have been made from APR, Section 2003(a)(1) funds in the amount of \$3,609,800. Iowa Western elected to distribute the funds in two phases; Fall 2021 and Spring 2022. The remaining funds in the amount of \$2,604,667 are scheduled to be distributed as Phase II at the start of the spring 2022 semester.

## **METHODOLOGY**

## PHASE ONE (FALL 2021):

### **ELIGIBILITY**

As of September 30, 2021, a total of 3,478 lowa Western students met the eligibility criteria.

• Must be enrolled for Fall 2021 and remain enrolled after 10 days and/or Administrative Withdrawal for Non-Attendance.

• Must be degree seeking.

## **DISTRIBUTION**

The need of eligible students will be scored based on the EFC on their current FAFSA and their Fall 2021 credit costs (# of credits). Awards will be distributed based on the total score of both EFC and credit costs. Students without a FAFSA on file will be considered low need.

- EFC/Need:
  - High need EFC= \$0-\$5,575 (4pts)
  - Moderate need EFC= \$5,576-\$20,000 (2pts)
  - Low need EFC= \$20,001+ (also no FAFSA on file) (0pts)
- Credit Costs
  - High = 11+ credits (3pts)
  - Medium=7-10 credits (1pt)
  - Low= 1-6 credits (opts)
- Total Need/Score (EFC + Credit Costs)
  - High Need= 6+ points
  - Medium Need= 3-5 points
  - Low Need= 0-2 points
- Award values were preset and based on criteria. No application required.
  - High Total Need= \$1200
  - Medium Total Need= \$1000
  - Low Total Need= \$800

### COMMUNICATION

All eligible students received two emails. The first was sent on August 31. The email informed students of potential HEERF aid and outlined eligibility. The second email was sent on September 8 to all eligible students. The email confirmed eligibility and informed each student of their award value and an estimated distribution date of September 16, 2021.
