Only 200 Phi Theta Kappa members are selected each year to receive this prestigious award which also comes with a \$1,000 scholarship. This year's recipients were selected by a panel of independent judges from nearly 900 applicants. Coca-Cola Leaders of Promise Scholars are selected based on outstanding academic achievement and demonstrated leadership potential.

Iowa Western Summer Camp Highlights

Pottawattamie Promise Update

Meaghan Milburn, Dean of Advising and College Success Programs, presented the Board with the Pottawattamie Promise Update. Highlights from the report include:

- Program overview: Participating Foundations include Iowa West, Peter Kiewitt and Iowa Western Community College.
- Eliminates barriers and offers opportunities for students in select Pottawattamie County high schools who would not otherwise be able to attend college.
- Provides students with wrap-around services that address academic and psycho-social needs
- Class of 2021 consists of 130 students from CBCSD, Riverside, Lewis Central, AHST and Tri-Center.
- Fall to Spring Retention for class of 2018 was 76%.
- First semester GPA 2.44
- High Impact Practices Intrusive Advising and Academic and Co-Curricular Supports
