President's Report

Dr. Dan Kinney, President of the College, reported on the following:

- Ann Lebo has resigned from the Iowa Department of Education.
- With the re-organizational bill a higher education division created that will combine community colleges with student aid commissions and others.
- Next week is Community College Day on the Hill. We will be taking our EMS program.
- Construction will be starting in Looft Hall.
- We are seeing an increase in campus visits.
- The Lt. Governor was in Shenandoah to promote an EMS pilot program they are looking at doing in Page and Fremont counties.

- The National Wrestling Tournament will be March 3, 4 and 5 at the Mid America Center in Council Bluffs.
- The ACCT Leadership Congress will be October 9 -12 in Las Vegas. Registration is open.
- The ACCT National Legislative Summit was held early February.
 It was well received and the group had good meetings with our delegation.
- Redistricting Dr. Kinney share a presentation with details on the new process for redistricting. We hope to have our first map this week.
